- Commitment to attending every full-day, monthly session (9 in total + Graduation)
- Desire to learn about the DeKalb County community and dedication to become more involved within it – at work, in government, in nonprofit organizations, etc.
- Past, current or future desire to volunteer in agencies directly benefitting DeKalb County.
- Ability to contribute to the overall experience of the DeKalb Leadership Academy: participating in the conversation, coming prepared to each class, asking questions and helping yourself and others get the most out of the academy.
- Knowledge or experience required to determine the issues present in DeKalb County along with the desire to be a part of the change required.
